Project Name: Aria solar power project

Project Applicant (Proponent): Aria LP

Project Location: The proposed site for the project is located on Wood Road in the Township of Tay.

Dated at the Township of Tay this the 1st day of December 2011.

Aria LP is planning to engage in a renewable energy project in respect of which the issuance of a renewable energy approval (REA) is required. The approval is managed by SkyPower Limited on behalf of the proponent. The proponent has received a contract from the Ontario Power Authority (OPA) for the sale of electricity generated by this renewable facility through the Province's Feed-in-Tariff (FIT) program (enabled by the Green Energy and Green Economy Act). The distribution of this notice of a proposal to engage in this renewable energy project and the project itself are subject to the provisions of the *Environmental Protection Act (Act) Part V.0.1* and *Ontario Regulation 359/09* (Regulation). This notice must be distributed in accordance with section 15 of the Regulation prior to an application being submitted and assessed for completeness by the Ministry of the Environment.

The proposed site for the project is located on Wood Road in the Township of Tay was originally called RayLight. This project has now been renamed to Aria.

Meeting Information:

In order to provide information to and consult with community members, stakeholder groups, First Nation and Métis communities and government agencies, SkyPower Limited is hosting a public meeting. At this information session you will be able to view information on the project, collect handouts, ask questions and provide comments directly to the proponent. This public meeting is a repeat of the public meeting held on September 6, 2011 (under the original project name of RayLight LP and the RayLight Project) due to project name change, public interest and regulatory requirements.

TIME: Between 6pm and 8pm

PLACE: Port McNicoll Legion Hall, 369 Armstrong Street, Port McNicoll, ON

Project Description:

Pursuant to the Act and Regulation, the facility, in respect of which the project is to be engaged in a Class 3 Solar Facility. If approved, this facility would have a total maximum name plate capacity of 9 MW AC. The project location is described in the map below. All components will be located within the project boundary areas as shown in the map. The project is being proposed in accordance with the requirements of the Act and Regulation.

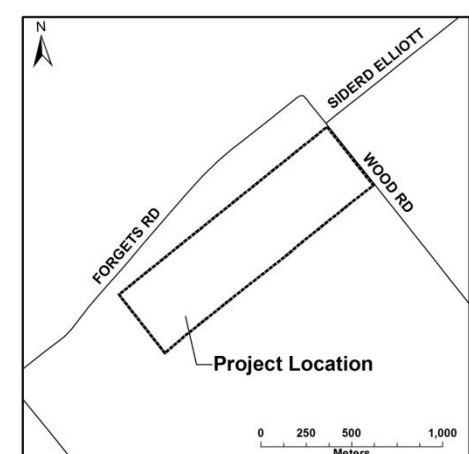
